Dear Town Manager Blodgett and Castine Selectboard:

On behalf of Maine Maritime Academy (MMA), GZA GeoEnvironmental, Inc (GZA) is submitting this application for a license from the Town of Castine under the Maine Wharves and Weirs Act, 38 M.R.S. §§ 1021-1027 ("the Act") for the proposed pier extension and mooring dolphins included in MMA's waterfront campus improvements necessary for receiving the new National Security Multi-Mission Vessel (NSMV) training ship. The proposed pile-supported structures are considered a "wharf" under the Act. The Act charges the Selectboard to make two determinations in granting a license based upon the following standards: (1) whether the proposed erection or extension of a wharf would be an obstruction to navigation, and (2) whether the proposed erection or extension would injure the rights of others. 38 M.R.S. § 1022. The following addresses both standards.

Standard 1: Will the proposed erection or extension of a wharf be an obstruction to navigation?

The proposed structures do not obstruct navigation. MMA has collaborated with adjacent waterfront property owners and the Town of Castine on the siting of the proposed structures. While the original pier design did not obstruct navigation, there were aspects of navigational maneuvers that were identified through this collaboration. In response, MMA was pleased to make accommodations, including modifications to the design, such as movement of proposed dolphins, to address concerns regarding navigation post-construction. We are most appreciative for the subsequent unanimous support of the Town Harbor Committee and the Town Planning Board that both considered these modifications in context of assessing impacts to navigation. Indeed, the Planning Board specifically found the proposed pier will not have adverse effects on navigation.

Please see the attached Figure 1: Proposed Pier Renovations to Berth the NSMV for the overall proposed layout plan. The plan includes clearance distances to the Town Dock to the east and to a potential pier at the abutting residential waterfront property to the west owned by J Edward Odegaard. Also attached are a letter from the Town's Selectboard recognizing the modifications to mitigate potential ingress and egress concerns at the Town Dock and a Letter of No Objection to the project from Mr. Odegaard who has provided consent. Both of the



letters were provided to the State of Maine Bureau of Parks and Lands for project review under their jurisdictional responsibilities.

Given these supporting letters from the direct abutters with navigation interests, the support of the Harbor Committee, and the approval of the pier by the Planning Board, the proposed project is not an obstruction to navigation.

Standard 2: Will the proposed erection or extension injure the rights of others?

The proposed structures do not injure the rights of others. Through the original design and above-referenced modifications, we are pleased to have been able to ensure that the project will not prevent the exercise of others to their riparian rights to wharf out and maintain ingress and egress to nearby properties. MMA has been pleased to participate in multiple, publicly-noticed meetings and hearings during which the interests and rights of all others have been solicited and received. This has included much input from citizens and officials throughout Castine. We have also worked directly with nearby property owners to address concerns.

In the attached Selectboard Letter to the Bureau of Parks and Lands, the Town recognizes the modifications that MMA incorporated to mitigate impacts to the Town Dock and indicated that adjustments of the Town Dock for further mitigation are not "unreasonable." In addition, the Castine Harbor Committee provided an Advisory Memorandum to the Selectboard at the April 3, 2023 meeting that states the Harbor Committee "accepts MMA's pier renovation project contingent upon the modifications and commitments to the Town stipulated in President Paul's 03/22/23 letter." The referenced commitments are those included in Eaton Peabody's May 18, 2023 letter to the Selectboard requesting project review under the Wharves and Weirs Act. Attached are the approved meeting minutes for the April 3, 2023 Selectboard meeting which document agreement by the Selectboard. Also attached is a copy of the draft Harbor Committee meeting minutes which includes the memorandum.

Pursuant to the Act and best practices, notices of intent to request a permissive license from the Castine Selectboard were sent via certified mail to parties that may be directly affected by the proposed construction. Copies of the notifications are attached.

As shown on the attached Figure 1, MMA's proposed project does not prevent build-out of a pier and floating dock at the abutting residential waterfront property to the west. The potential pier and dock layout shown on the figure was provided by Mr. Odegaard for use in evaluating siting of MMA's proposed structures. As referenced above, this property owner has provided a letter of no objection and consent to the MMA project.

Given the above coordination with citizens of the Town of Castine and nearby affected property owners, the proposed project does not injure the rights of others.


This letter is in response to the public notice, dated March 24, 2023, that the Town of Castine received on or around March 28th, 2023. The notice invited comments from the Town of Castine, as an abutting property owner, on the Department of Agriculture Conservation and Forestry (DACF) submerged lands lease review. This review was stimulated by Maine Maritime Academy's (MMA) planned pier reconstruction and expansion which the school is undertaking to be prepared to receive its new National Security Mulit-mission Vessel training ship. Below are Castine's comments.

The four review criteria listed in the notice all hinge on what is considered an "unreasonable" interference or diminishment. It is Castine's understanding that it is up to the BPL to define what is to be considered "unreasonable". The project, as it is currently designed will have an impact on our town dock area as our landing floats are immediately to the East, and upriver, from the project area. Please see the attached drawing for a visual. Owing to the confined spaces involved, this project will have an impact on boater ingress and egress navigation to Castine's town dock area. MMA has made several design adjustments to their plan at our request which have mitigated this issue to a degree. However, Castine assesses that to address this issue with finality, Castine will be forced to adjust the infrastructure of its town dock area to ease the ingress and egress course angles for boaters utilizing Castine's town dock facility. With a project of this magnitude, scope, and importance, we do not assess that the infrastructure adjustments that Castine will be required to make are unreasonable.



- -Bob Scott said he had good information about guardrails. Shawn said he thinks he's received an email from Bob with the information but would confirm.
- -Mark Morgioni asked when the Fire Rescue Dept training exercises at the former Torno property would be taking place. Exercises will start Sunday, 4/9 in the late afternoon not to interfere with church (Easter) services.
- -Jerry Paul thanked the Harbor Committee, Selectboard, Town Manager & Harbormaster for their support regarding the Pier Improvement & Expansion project. He said it was impressive attending the mtgs and work put in to reach a goal. He is looking forward to the Town and Academy working together to get the best overall which includes combined resources for funding for this project and others in the future.
- Helen Miller said she was extremely upset & disappointed with the way the Town has handled the Bicentennial /Women's Suffrage Celebration, cancelled 3-years ago due to the pandemic and the return of fundraising funds. Helen said she raised over \$100,000 and people are still asking her for updates. She said when she asks the Town for updates she gets the runaround. Colin, as the Bicentennial Chair, apologized to Helen that she felt the way she did and for the lack of communication. Shawn gave a review of developments and items that have been worked on especially with the Oliver Hazzard Perry. The Town and Bicentennial Committee is still trying to figure out what to do with remaining funds. Bobby Vagt, member of the Bicentennial Committee, said he was sorry that Helen felt like she did too but she alone did not raise the money. A letter was sent out from the Committee to all those who gave donations letting them know if they wanted a percentage their donation returned, as some had been spent on deposits, to let the Committee know. An address and phone number was on the letter. We were lucky that many did not want funds returned. Many people have been working on this matter and have tried to preserve the funds to use in the future. Unfortunately, we do not know yet what will be next.
- -Josh Adam asked what the process was for when the Selectboard receives correspondence and decisions are made for what correspondence is recognized at mtg. He said at the last mtg 4 correspondences were issued but only 3 were recognized. It just so happens that Kevin Coady was present at the mtg, therefore, the letter from his attorney was addressed.

Josh asked if the Selectboard make a point to hide things or pick and choose what they address in public and what is handled in secret.

Gus asked when there would be a mtg regarding the fire station. He is upset that there have been important mtg not open to the public. Gus was corrected that there has never been any important mtg NOT open to the public.
- -Selectboard member, Roberta Boczkiewicz said she had been to a seminar recently with other Selectboard members of Maine communities present and they were completely surprised when Roberta told them that Castine zooms mtg and allows public participation. Many communities do not do that.

Town Manager's Report

1. Fire Department Training. In conjunction with the imminent demolition of the home at 116 Perkins Street by the Wilson Museum, the Castine Fire Rescue Department will be taking advantage of this upcoming demolition to conduct training within and on the building before it is torn down. There will be no burning of the building but a smoke machine will be utilized so that the CFRD can conduct SCBA (airpack) training within an actual structure. Residents may see smoke in the local area but should not be alarmed. The CFRD will also be training on forcible entries and in the cutting of roofs. Other local fire departments may also be training on this building, but the primary focus will be on the CFRD. The training will be taking place on Tuesdays, Saturdays and Sundays with approximate hours of mid-afternoon through 8:00 PM.

2. American Rescue Plan (ARPA) Funds Update. As the attendees to the upcoming annual town meeting in May will see, we will request that the town's remaining ARPA funds of \$52,446.31 be used on two things. First, we are requesting \$42,446.31 funds for sidewalk refurbishment from the Court Street/Pleasant Street intersection down to Perkin's Street. Second, we will be requesting that the town authorize amount amount not to exceed \$10,000 on the town hiring a contracted grant writer. If bids come in lower than projected, specifically on the Sidewalk refurbishment, we will return to the town to




request authorization to spend the remainder on roadway guardrails for Water Street.

- 3. Community Resiliency Partnership Grant Update. We are awaiting Efficiency Maine to provide us with the final incentive numbers for the lighting upgrades before we can actually receive our CRP grant money. Efficiency Maine has had our paperwork for over a week, so we are hopeful to receive the official incentive offer back this week. Once we receive the incentive paperwork from Efficiency Maine, the state office of Innovation and the Future can release the funds and we can schedule the work to be done. I will project that this work will not begin at Emerson Hall until late May at the earliest and we will want to wait until after the Adams School releases for the year on June 15th to accomplish the Adams School portion of this project. On a related note, we are expecting the Emerson Hall heat pump installation to take place on May 3d and 4th.
- 4. MMA Pier Expansion Update. The town has received Maine Maritime Academy's Pier expansion project permit applications. This project is the sole agenda item for this Thursday's work session (6th) and the public hearing posted for the 13th of April, 7:00 PM at Emerson Hall.
- 5. Town Dock Floats going in on April 14th. Subject to the weather, the town dock floats will be going into the water on the 14th. Castine public works is putting the finishing touches on the remaining two floats and they will be completed in the next day or so. For those that don't know, our public works crew have sequentially re-built all of the town's floats over the past three years and are wrapping the remaining couple this year.
- 6. Town of Castine Seeking a Public Works Employee. Castine's public works crew is back down to a crew of one. By tomorrow, the town will start



advertising to hire a second member of the team. Details of the position will be on the Castine town web page and hard copies will be available at town hall.

- 7. Town Office Closed on the 6th of April. I will be out of town from the 6th through the 11th of April and Karen and Sue will need to go to Ellsworth to proof this year's town report on the 6th. I respectfully request that the Selectboard authorize us to close Emerson Hall on the 6th of April due to no staff availability.
- 8. Selectboard Work Session Wednesday the 12th. One of the better changes we have made recently is to hold off cycle work sessions for the Selectboard. Is the Selectboard available on the 12th of April at 9:00 AM for a work session?
- 9. Maine Maritime Academy 2021-22 Voluntary Contribution. The town has received MMA's voluntary contribution for the past year totaling over \$150,000. Yet to be received will be another tranche of approximately \$5,000. Often, lost in conversations regarding MMA, it is lost on some residents just how much MMA gives back to Castine, so I want to take this opportunity to highlight one example.
- 10. Drummond Woodsum Law Firm: Kevin Coady Letter. Due to an extraordinarily busy period, no further research has been completed on this letter, but I hope to be able to get to it in the very near future.

Last meeting's minutes were approved.

Harbor Master Report:

New Business:

- Vote to submit the Advisory Memorandum re: Proposal for new MMA pier to the Town Select Board.
 - David Wyman read the following statement into the record:

MMA is an important part of the Castine community, and I totally support MMA in their need for an appropriate pier and waterfront to handle the new ship. After listening to the discussion at our working sessions and reviewing the message from Jerry Paul, I have concluded that the current MMA pier addresses the ship docking requirement but ignores the surroundings and the big picture of other future sea level rise problems. The new pier design creates a navigational hazard for those approaching or leaving the town dock. The only logical justification for moving the pier offshore from its present location is if deeper water is necessary to accommodate the new ship's draft, which is not the case. I also understand that for safety reasons, the working area of the pier should be as level as possible.

As it would be best to find a design solution that minimizes the area of the pier that is at a slope, a single lane access from the parking lot level to the new pier level would seem to be appropriate. In addition, any design should be consistent with the surroundings, primarily the existing town waterfront. There are multiple possible design solutions that put the new pier in the approximate location of the existing pier, and the harbor committee has offered a variety of better pier design concepts for consideration by MMA. Below are a few:

- 1) L shaped ramp that I previously submitted for consideration
- Pleasant street could be continued down the hill at its existing slope until it reaches the level of the new pier by using a single lane bridge in the area of the present outside stairs.
- 3) The entire new pier could be built level at the required height and then accessed via a lift platform or Syncrolift type elevator.
- The new pier could include a loading dock for unloading trailer trucks with a forklift
- 5) The pier could be built at an intermediate level which includes a LEGOS type top layer that could be added to the pier later when entire area is raised.

It is apparent that none will be considered by MMA at this point. As a result, we have also looked at potential modifications to the town pier/floats that could help to lessen the impact of the MMA pier, but it should not be the town's sole responsibility to adapt to MMA's poor design.

ADVISORY MEMORANDUM

In response to Maine Maritime Academy's (MMA) proposed pier renovation project designed to accept the National Security Multi Mission Vessel (NSMV), the Harbor Committee hosted several working sessions to discuss and review the proposal. The working sessions were held on 02/28/23, 03/09/23 and 03/21/23. The committee members acknowledge the importance and urgency of MMA's preparations for the NSMV imposed by the United States Maritime Administration. The preservation of access and safety to Castine's waterfront are of paramount concern to the Harbor Committee whose members have raised concerns regarding the approaches to the Town and Acadia Docks.

President Jerry Paul summarized MMA's commitment to work with the Town of Castine to address concerns arising during the working sessions in the attached letter dated 03/22/23.

The Harbor Committee is of the opinion that modifications and reconfigurations for the town float systems at the Acadia and Town Dock are necessary to mitigate the concerns for safe navigation and convenient access to and from the town's waterfront, which is vital to its economic wellbeing. The Harbor Committee recognizes that collaboration and cooperation between MMA and the Town of Castine is in the best interest of both parties. Therefore, the Harbor committee accepts MMA's pier renovation project contingent upon the modifications and commitments to the Town stipulated in President Paul's 03/22/23 letter.

It should be noted: It is the view of the Harbor Committee that there are design concerns and suggestions for the new MMA pier facility that were not adequately studied or addressed in the timeframe available to the Harbor Committee. It is recommended that as plans for Phase II development (as referenced in the 03/21/23 working session) progress that the Town and MMA commit to a collaborative and cooperative process to raise the base grade elevation and reinforce the continuous bulkhead in response to sea level rise projections. The waterfront infrastructure from boat ramp to beach is essential to the prosperity of both the Town of Castine and MMA.


